Dr. (Mrs.) Medha Vishram Kulkarni ji,

Kindly refer to your letter dated 17.01.2025 regarding formation of Defence Corridor in Maharashtra.

The matter has been examined. Maharashtra has a developed ecosystem of defence production which includes manufacturing units of DPSUs like HAL, BEL, MDL, MIL, YIL, AVNL, private defence players like L&T, Tata Motors, Bharat Forge, Mahindra etc. along with DRDO labs/establishments and several Defence Institutes. Government of India has issued total 95 Defence Licenses to Private Companies in Maharashtra. To boost innovation in defence manufacturing in state of Maharashtra, 88 iDEX winners and three partner incubators i.e. Society for innovation and Entrepreneurship, IIT, Mumbai; Venture Center a CSIR initiative and Marathwada Accelerator for Growth and Incubation Council are engaged.

Apart from the above, Government of India has taken various steps to promote domestic defence manufacturing which include launch of Indigenization portal SRIJAN for Services/DPSUs with an industry interface to provide support to MSMEs/Start-ups/Industry; de-licensing of large number of items which previously required license for defence production etc.

The entrepreneurs of Maharashtra may take advantage of these initiatives and be part of the global supply chain of defence manufacturing.
